UNOPPOSED MOTION TO DISMISS PLAINTIFF'S CLAIMS

2. Bradley was a loving son, brother, and father of five young children. He was known for his warm nature, his contagious smile, and his exceptional empathy for others around him, even as he grappled with his own personal challenges. Importantly, Bradley made it a point to be there for his children. His eldest child was ten years old when Bradley was killed; the next to eldest, his namesake, was eight; his eldest daughter was four; his youngest son was two; and his youngest child, his baby girl, was only one year old. To them, he was "daddy." Bradley labored to
